**Entries:** **Deadline to register and submit payment is Friday, August 18, 2023, for both online or paper registration.**

**Limits for Entries:** Players are limited to two (2) events; one singles and one doubles or two doubles. One doubles must be mixed.

**Minimum No. Players:** All events must have a minimum of four (4) participants or you will be moved to the next lowest event.

**Indoor Courts:** There will be a \$5.00 fee per person, per day, if indoor court time is needed due to inclement weather

**Eligibility:** Players must be current financial members of one of the Tri-City Clubs to participate in the tournament: Forest City Tennis Club, Motor City Tennis Club or Chicago Prairie Tennis Club. Membership will be verified. Please contact your local Tri-City President to confirm your membership status.

**Tournament Format:** All matches, unless otherwise stated, will be the best two (2) out of three (3) sets, scored under the No-Ad system through the quarters. A twelve (12) point tiebreaker will be played when any set reaches six (6) all. There will be a 30-minute default time on the first day of play and a 15-minute default time thereafter. Players who have not reported ready for play/checked in after the match is called will be defaulted.

**Draw:** Draw will be held on Saturday, August 26, 2023, at 11:00AM. Each Tri-City Club President should email seeding and ranking information to [chicagoprairietennisclub@aol.com](mailto:chicagoprairietennisclub@aol.com) no later than Friday, August 25, 2023.
